

Pricing

- All pricing proposals are confidential and valid for 60 days. Product and freight estimates are subject to change should there be any modifications to stock codes, fabric grades/selections, options, shipping services, or ship to destination.
- Prices exclude shipping, installation and sales tax.
- Prices are F.O.B. factory loading dock Matamoros, Mexico.

Sales Order Revisions & Cancellations

- Orders cannot be canceled or changed without written consent from Kwalu, which may be granted or withheld based on conditions, service charges, or price adjustments.

Credit App/Deposit

- New customers must submit a credit application unless the order is prepaid in full before production.
- The information on the credit application must match the billing customer on the purchase order.
- Customers without order history in the last 3 years must provide an updated credit application.
- Deposit terms are assessed on an order-by-order basis, considering credit report, limit, history, and order size.

Taxes

- Customers must provide proof of tax exemption; otherwise taxes will be applied.
- Sales taxes are calculated based on the final product destination.
- Canadian orders incur GST unless third-party shipping is arranged and paid by the customer.
- Hawaiian orders are subject to GET.

Payments

- All credit card payments incur a 2.5% fee.
- Payment terms are NET 30 or otherwise noted.
- Customers with past due balances may be subject to shipping holds.
- Orders sent to collections will incur collection fees plus an interest charge of 1% on the unpaid invoice amount, compounded monthly.
- All sales are in USD and payable in USD.
- To protect against fraud, Kwalu recommends payments via ACH or wire.
- Payments will be allocated to the oldest outstanding invoices unless specified otherwise.
- Deductions or adjustments require prior approval from the Kwalu accounting team.

This document outlines the terms and conditions of the limited warranty provided by Kwalu. Below are the specific details regarding the duration of coverage and exclusions.

Limited Warranty Coverage

Eligibility: This warranty applies exclusively to the original purchaser and is non-transferable. To be eligible for coverage under this limited warranty, you must purchase the product directly from Kwalu or an authorized dealer. It is valid only under conditions of normal use and begins on the shipping date.

Conditions: The warranty will be voided if the product is modified without authorization, misused, abused, or used for purposes other than its intended design.

General Warranty Provisions

We reserve the right to modify the terms, coverage, or conditions at any time with prior notice.

If a product is discontinued, we will provide a suitable alternative in accordance with the original warranty terms, reflecting our current product offerings. If a direct replacement is unavailable, we will work with you to find a comparable solution.

Labor, service, and freight or other shipping charges will be covered if they fall within the conditions outlined in the warranty matrix below. Motorized beds are only eligible for coverage as outlined in the warranty matrix below and will be excluded from any additional warranty terms.

Custom products will be covered under the same warranty conditions as the original item they are modeled after.

All claims will be subject to inspection and analysis to determine the cause of the issue.

Shipping Damage

Customers are responsible for inspecting all products upon receipt. Any loss or damage must be reported to Kwalu within 5 business days – no exceptions. Kwalu will handle filing any related freight claims but does not accept responsibility for loss or damage incurred during third-party shipping.
